




# ANB & ATB Overview

## **Evaluate Necessiteis & Capabilities**

- Scope Assessment (Evaluate own scope)
- Start communication with ANB by choosing directly ANB based on scope assessment (AM ANBs information will be available on EWF website) Contact EWF (ewf-iab@ewf.be) and EWF provides possible ANBs
- Check Conformity with EWF AM Syllabus (Access EWF's Public Guideline (available at www.ewf.be) and Ask ANB access to EWF's Private Guideline)
- Facilities and Equipment (Health and Safety Requirements; Tools for Practical Work; Appropriate Classrooms; Good quality visual aids)
- **Teaching Staff Connection to the Industry** (Teaching abilities Competence in course subjects; Sufficient number of teaching staff; Close relation with the industry)
- **Documented Timetable** (Programme lecture by lecture; Indicate subject; Teachers and reference to EWF AM Syllabus)



Benefits of becoming an AM ATB?	<ul> <li>AM ATBS are in advantage over other training organisations, as they are the only ones that can deliver IAMQS training and are part of a strong cooperation network.</li> <li>The main advantage sin becoming AM ATBs:</li> <li>Industrial oriented training</li> <li>Quality Assurance</li> <li>Establishment partnerships for cooperation - AM ATB can easily cooperate with companies to have access AM equipment, as well as with other ATBs to share resources or even complement their scope of training</li> </ul>
Degree of freedom to provide the training (i.e., language, contents,)	<ul> <li>The AM ATB has flexibility to decide about the languages and modes of delivery form the AM Courses, as long as the minimum quality standards are met. The degree of freedom for AM ATBs is related to:</li> <li>define the training implementation plan, namely the timetable, scheduling and frequency of the sessions</li> <li>define the context for the course implementation, either online, face to face or blended</li> <li>address more contents than the ones recommended in the training guidelines</li> <li>address less contents than the ones recommended, if the reduction (of contact hours) is not higher than 20%</li> <li>use and develop the training materials for the courses</li> <li>select the resources (e.g., equipment, trainers)</li> <li>implement the training in national language</li> </ul>







# Can I establish collaboration with other training organisations (Non ATBs) to deliver the AM course?

Yes, it is possible to run IAMQS courses in collaboration or jointly with any other establishment, since only one organisation accepts the overall responsibility for the course; An agreement between the organisations involved is required in order to implement the course, being the agreement the responsibility of the AM ATB.

Do I have to pay to become an ATB? /Who definesYes. The fee for becoming an AM ATB and implementthe cost of the course's delivery?IAMQS guidelines is defined by the AM ANB.

As an ATB do I have any minimum compromise with IAMQS of training per year or similar? What happens if I cannot deliver training for more than 1 year?

As an ATB, do I need to provide the training of a completed Professional Profile or can I also provide it on separate CUs?

The contractual arrangements define the conditions in which the AM ATB has to implement IAMQS. The costs depend on the business Model of the AM ANB

The AM ATBs are delivering courses for an approved scope of activity, which can be a full Qualification /Professional Profile or separated Competence Units.

#### PROCEDURES FOR APPROVING AM ATB



The AM ANB assesses the application based on conditions set by procedures elaborated and updated by EAMQC (AM Rules).
